- 1984 Building leased to outside management (Tenet)
- 1998 Tenet leaves and BCHD focuses on preventive health
- 2010 The Beach Cities are chosen for the Blue Zones Project

- Help move the planning process forward in the spirit of cooperation
- Regularly participate in Working Group meetings
- Understand the role of BCHD as a public organization and its regulatory obligations



Healthy Living Campus Project: Guiding Principles

- Develop community for older adults
- Create integrated hub of well-being
- Incorporate Blue Zones Project concepts
- Focus on emerging technologies and innovation
- Grow the enterprise to support the mission
- Actively engage community/stakeholders
- Prioritize environmental sustainability and accessibility
- Create open/green space by shifting parking to the perimeter

Healthy Living Campus Project: Community Needs

Demand Study and Surveys (2016): Housing for Older Adults

- "Silver Tsunami": seismic increase in over-65 population by 2020
- Limited options for 15,000 older adults in Beach Cities
- Assisted and independent housing for older adults in Beach Cities at or near capacity
- Wait lists for assisted-living facilities up to 3 years
- Lack of housing that provides a continuum of care (mixed independent and assisted)



Challenges and Needs of Our Older Adults



- 12% of Beach Cities residents are 65 years or older
- 1 in 3 adults 85+ will have dementia in their lifetime
- 94% want to stay in their community
- Up to three-year waiting list for older adult communities
- Isolation
- Transportation challenges
- Health care

Healthy Living Campus Project: Need/Feasibility

Existing 514 N. Prospect facility built in 1955

- Repair costs increase as building ages
- Aging systems in need of modernization
- Maintaining current 90% lease rate requires improvements

- Topographic Survey
- Geotechnical Assessment
- Design-Build Authority at State Level, Assembly Member Al Muratsuchi (AB 994)
- Campus Discussion with staff at Strategic Planning Meeting
- Board Planning Sessions
