1 INTRODUCTION

Beach Cities Health District (BCHD) has developed a Community Working Group (CWG) to engage local participants in planning for its Healthy Living Campus (HLC). The CWG is an informal, voluntary group of stakeholders from each of the three Beach Cities who represent a broad range of local interests. The group is comprised of leaders from local businesses, civic organizations, older adult services, the Blue Zones Project and neighboring residents, and participation is by invitation and recommendation from the BCHD board and staff.

This report summarizes recent CWG activities and feedback received at the fifth CWG meeting.

1.1 Purpose of Community Working Groups (CWG)

Community Working Groups (CWG) provide a forum for integrating local input into the design of projects like the HLC. CWG participants represent the interests of a community group, service, agency or organization and serve as an ambassador of these interests. CWGs are limited in scope to the planning and design of the project, are not a formal voting body and are organized to enhance local input into the planning process.

2 CWG MEETING NO. 5 - SEPTEMBER 18, 2017

2.1 Overview

The fifth CWG meeting for the HLC convened in the Beach Cities Room at 514 N. Prospect in Redondo Beach. The attendee list, made up of involved community members and diverse BCHD stakeholders from all three communities, was developed by staff and reviewed by the Board.

Fourteen (14) members attended this meeting, and seven (7) members were unable to attend. The CWG meeting room was arranged in a U-shaped configuration that faced a presentation screen. The format provided opportunities for participants to actively engage in meaningful discussion and share valuable information, insight and feedback with the staff and project team members.

The meeting was facilitated by Valerie Martinez of VMA Communications and included a PowerPoint Presentation (Appendix A). Valerie led the presentation, which began with a summary of the outreach conducted and feedback received in August and also explained the plan refinements that have been made to reflect the feedback.

Leslie Dickey, Executive Director of Real Estate, then presented the preliminary plan refinements, including changing a building configuration to maximize green space. He reviewed the competing priorities in consideration of the parking structure proposed for the Beryl and Flagler lot. Next, Leslie presented visualizations of the campus before and after from various viewpoints in the surrounding area. Finally, Leslie shared a cross section of the campus so the CWG members could get a sense of the building height of proposed structures in relationship to the existing structures.

Valerie shared information for the upcoming Community Open House Meeting and distributed a sign-up sheet so CWG members could volunteer to help staff the event.

Throughout the meeting, CWG members were encouraged to contribute their feedback verbally and also in writing on the comment cards provided.

Reminder e-mails were distributed to CWG members on September 13 (Appendix B). These e-mails provided CWG members with information about the September 18 meeting and a link to the project website address. Following the meeting, thank you emails were distributed to those who attended the meeting (Appendix C.1) and those who were unable to attend (Appendix C.2).

2.3 Summary of Feedback

Feedback was solicited throughout the meeting and via written comment cards, and is summarized below.

Traffic:

- Pat A. asked if we have traffic studies yet. Bruce S. mentioned that a City of Torrance department conducted a study, but it has not been made available. Leslie replied that traffic studies will be conducted as part of the environmental review process, which has not yet begun.
- Bruce S. asked if a stoplight would be placed at the corner of Flagler and Beryl. Leslie indicated that the decision would be made by the City of Torrance, but it would be made based on the traffic studies conducted during the environmental review process.

Outreach:

The group had questions and suggestions regarding outreach:

- Pat A. asked if BCHD had talked to the City of Redondo Beach yet. Leslie said there have been conversations and BCHD has shared preliminary plans.
- Bruce S. asked if BCHD had talked to Von's or other tenants of the nearby shopping center. Leslie answered that they are indirectly aware because they have the same property management as BCHD.
- Sue A. asked when information about the residential units will be available and mentioned there is significant interest among the older adult population. Val explained that we are at the point in the process where we are just determining the basic outlines of proposed buildings and more detailed information would be available as the project progresses. Sue suggested having information targeted to the seniors who will be attending the Open House in hopes of getting information about the residential units.
- Pat A. suggested putting all information on the website, including all visuals and maps because it helps to stop speculation. Eric reminded the group that all meeting materials, drawings, visuals, maps, comments received and board reports are put on the website.
- Craig C. suggested putting information up as individual, high-resolution files so it is easier to find and so it is possible to zoom in to inspect details.
- Dency N. mentioned that in his preliminary conversations with individuals about the design-build legislation, he has heard concerns that BCHD's effort to cut costs by pursuing a design-build contract potentially means lower quality. Leslie explained that design-build actually provides more opportunity to select sustainable materials, whereas the alternative process, design-bid-build, requires that the lowest cost bidder be selected. He reminded the group that sustainability is a guiding principle that the BCHD Board of Directors established for development of the HLC. He explained that BCHD looks at life-cycle costing, such as the current roofing being considered. While it is the most expensive, it also has the best energy savings and the longest life.
- Pat D. suggested ensuring that the BCHD Board of Directors be provided all information that has been given to the CWG. Eric reminded the group that a comprehensive board report is sent following every meeting.
